- Reservation fee is \$80 per booth, maximum two booths.
- Reservation request must be accompanied by booth fee (non-refundable). If booth space is exhausted, fee will be returned immediately.
- All booths are outdoors and are 20 feet by 20 feet. Tables are not available. Electricity is not available.
- Booths will be assigned on a first come, first served basis. **REQUESTS FOR SPECIFIC BOOTH LOCATIONS CANNOT BE PROMISED!**
- Confirmation, including four complimentary admission tickets, will be mailed by September 20.
- The event may be postponed or cancelled if the field is too wet, even if rain has stopped. Because the field is on town-owned property, organizers must abide by the wishes of the town of Harvard.
- The Flea Market sponsors reserve the right to prohibit the sale of dangerous or offensive materials, or of any items causing immediate litter.
- Boothholders **must** agree to vacate the field, leaving no items or trash behind, by no later than 5 p.m. on the day of the Flea Market.
